Training, development and registration (clinical bioinformatics - genomics)

You can enter bioinformatics genomics [1] through the NHS Scientist Training Programme or Higher Specialist Scientist Training.

Training and education programmes

If you get a place on the <u>NHS Scientist Training Programme (STP)</u> [2] you'll be employed in a fixed-term, salaried training post and study towards a relevant masters degree in clinical science.

If you are a registered and experienced clinical scientist, you can apply for <u>Higher Specialist</u> Scientist Training (HSST) [3], where you'll study towards doctoral-level qualifications.

Programmes are often supported by the development of workplace-based assessment tools, assessment of equivalent learning and the development of academic careers.

Continuing professional development

No matter what level you are working at, as part of your development you will be expected to do 'Continuing Professional Development' (CPD) to show that you are keeping yourself up to date with the policies and procedures in your area of work.

Accredited Scientific Practice- development opportunities for healthcare science staff

Accredited Scientific Practice (ASP) provides an additional route for your ongoing professional and scientific development as part of the healthcare science (HCS) workforce. ASP allows employers to develop bespoke, responsive, short course programmes to meet training needs within the HCS workforce. ASP programmes provide you with a quality assured, rigorously assessed qualification which can lead to voluntary professional registration with the Academy

for Healthcare Sciences (AHCS).

An ASP programme involves work based learning with academic study of modules from the National School of Healthcare Science portfolio programmes. Access to an e-portfolio is provided to record learning in the workplace while associated academic study is completed independently through an accredited university provider. In some cases, completion of academic study may also lead to an award of a postgraduate qualification from the university provider.

Registration

As a clinical scientist, you'll need to be registered with the <u>Health and Care Professions</u> Council (HCPC) [7].

Clinical scientists must also hold an Academy for Healthcare Science (AHCS) Certificate of Attainment granted upon completion of the MSC Scientist Training Programme or AHCS Certificate of Equivalence.
